

**ALEPPO TOWNSHIP AUTHORITY  
MONTHLY MEETING MINUTES  
DECEMBER 17, 2020**

**Call to order**

Chairman Dan Darragh called the Zoom meeting, due to Covid-19, to order at 6:30 p.m. Those in attendance were Rich Zahrobsky, Glenn Baggley, and Dan O'Malley. Engineer Dave Kerchner and Solicitor Chris Lovato were also present.

**Minutes**

Dan O'Malley made a motion to approve the minutes from the November meeting. Glenn Baggley seconded. The motion passed unanimously.

Glenn Baggley made a motion to ratify the prepaid water and sewer bill lists and pay the December water and sewer bill lists. Rich Zahrobsky seconded. Both motions passed unanimously.

**Engineer's report**

Dave Kerchner reported he and Bill Davis met with an engineer at the Deer Run pump station to talk about a new system integrator. The cost to repair both sewer pump stations should be about \$45,000-\$46,000. Dan Darragh asked what kind of time frame it would take. Dave reported about three months due to drafting of bid documents. Dave reported the alarm systems have fallen short from day one and many previous system failures and broken pumps could have been avoided. Dave suggested some of the work should be done if not all the suggested repairs.

An updated budget draft for water and sewer were provided to the Board for review. **Dan O'Malley made a motion to approve and adopt the water budget for 2021. Glenn Baggley seconded. The motion passed unanimously.** The sewer budget will be adopted in January once the debt service amounts for Aleppo and Sewickley are determined.

Dave reported there is no updates to the sewer project study for surrounding municipalities and parts of Aleppo. The township manager discovered an old report that will be helpful to the study.

The Board gave Nicole authorization to begin collections on delinquent accounts in January once the solicitor reviews the standing regulations, per covid-19.
